Charges for Fail to Display Driver's License, Expired License Plates, and No Valid Inspection Certificates, may be dismissed by the Court if remedied and presented to the court within 10 days of the receipt of the citation. An administrative fee of \$10.00 will be charged. Registration or Motor Vehicle Inspection **CANNOT** be dismissed if over 60 days out of date.

4. IF YOU WISH TO ENTER A PLEA OF NOT GUILTY so indicate in the proper space provided below and return by mail or in person, no later than the appearance date shown on the citation. IF YOU FAIL TO RESPOND TO THIS CHARGE BY THE APPEARANCE DATE SHOWN ON THE CITATION, AN ADDITIONAL CHARGE MAY BE ASSESSED AGAINST YOU FOR FAILRE TO APPEAR, AND A WARRANT ISSUED FOR YOUR ARREST. IN ADDITION YOUR DRIVERS LICENSE MAY BE SUSPENDED.
5. You may be eligible to take a Driving Safety Course if you bring in a copy of your Texas Driver's License, Valid Proof of Insurance, State Fees of \$95.00 and appear no later than the appearance date on the Citation, If you are a CDL holder, you are not el for DDC or Deferral.
