You do not have to wait until the Docket Call day to give your announcements, but they must be made prior to or on Docket Call day. No announcements will be taken after Docket Call day. All motions for continuance must be filed prior to docket call. If you file a motion for continuance you should contact the court coordinator to schedule a hearing before the docket period begins.

NUMBERING OF CASES: You may call and get your number on the month long docket any time the week following Docket Call day.

IF YOU REQUIRE MORE THAN A 40 PERSON JURY PANEL YOU MUST FAX A REQUEST IMMEDIATELY AFTER RECEIVING THIS DOCKET. FAX NO. (409) 784-5849

ALL CASES MUST BE MEDIATED BEFORE THEY ARE CALLED TO TRIAL!!!!!!

YOU DO NOT HAVE TO CALL THE COURT TO GET A DATE AND TIME FOR SUMMARY JUDGMENT HEARINGS ON ASBESTOS OR SILICA CASES. ALL THESE MOTIONS FOR SUMMARY JUDGMENTS WILL BE HEARD AT PRE-TRIAL YOUR NOTICE SHOULD REFLECT THAT. THE COURT WILL NOTIFY ALL COUNSEL WHEN PRE-TRIAL IS TO BE HELD.

TRY OR DISMISS: Plaintiff's failure to announce "READY" on a case designated as "TRY OR DISMISS" by Docket Call day will result in that case being DISMISSED FOR WANT OF PROSECUTION (DWP).

NOTE: Some cases may have multiple settings. If your case on this docket is also currently on an earlier docket, it does not mean the earlier setting has been passed.
